# **Snagajob California Privacy Notice**

## Last Updated: September 5, 2024

Below is a summary of Snagajob's collection and use of "personal information" (as defined by the California Consumer Privacy Act ("CCPA")) about California residents in connection with our websites and mobile apps that link to this page. This Privacy Notice applies to information that we collect and process when you interact with our website and applications and related online and offline services (collectively, the "Services"). For more details, you can read our <u>Privacy Policy</u>.

This notice provides information about our practices in the 12 months leading up to the effective date of this Policy in relation to the categories of personal information that we collect from California residents generally – including the categories of sensitive personal information (race, ethnicity, health information, citizenship status, precise location information) – the purposes for which we use the information, the categories of third parties to whom we disclose the information for business purposes, our "sales" and "sharing" of information (as defined by the CCPA), and retention practices.

### B. "Sale" and "Sharing" Opt-Out Right

California residents may opt out of the "sale" and "sharing" of their personal information. As explained in the "**Notice of Right to Opt Out of Sales of Personal Information and Processing/Sharing of Personal Information for Targeted Advertising Purposes**" section in our Privacy Policy, we sometimes disclose information to unaffiliated third-party advertising providers for targeted advertising purposes, so that we can provide you with more relevant and tailored ads regarding our services, or regarding products and services from our partners and advertisers. We also use analytics partners to assist us in analyzing use of and interaction with our services, includi9ng emails and ads, and understanding our user/customer base. The disclosure of your personal information to these third parties to assist us in providing these services may be considered a "sale" of personal information under the CCPA, or, the "sharing" of your personal information for purposes of "cross-context behavioral advertising."

Please note that we do not knowingly sell the personal information of minors under 16 years of age without legally-required affirmative authorization.

Please note that if you have a legally-recognized browser-based opt our preference signal turned on via your device browser, we recognize such preference in accordance with applicable law.

### C. "Shine the Light" Disclosure

The California "Shine the Light" law gives residents of California the right under certain circumstances to opt out of the sharing of certain categories of personal information (as defined in the Shine the Light law) with third parties for their direct marketing purposes. We do not share your personal information with third parties for their own direct marketing purposes.

#### D. Retention

We will keep your personal information for as long as necessary to fulfill the purposes described above, unless a longer retention is required or permitted by law. We may delete or de-identify your information sooner if we receive a verifiable deletion request, subject to exemptions under applicable law. The retention period that applies to your information may vary depending on the services you use and how you interact with them. We may retain cached or archived copies of your information.
